Running for re-election, BOE member for 12 years, is on the 4th term, is BOE president now; was 1st and 3rd grade teacher in Great Meadows and is principal in Madison, is president of the Teacher's Union, completed a Dr. of Education, NJ School Board Association member, is a trainer, also paid for by the NJ School Board Association, is going to School Board Association convention and is presenting; lowa Lighthouse Study, says all BOE activity should be to support students, helped establish full day kindergarten, supported and expanded Gifted and Talented, STEM, middle school clubs, supported Solar Garden Projects at Cucinella and LVMS, security upgrades, believes in supporting the whole child academic, emotional and psychological support, may help establish a foundation for alternative sources of funding, looking into supporting teachers with grant funding, will be speaking tomorrow on relationship of superintendent and school board in Atlantic City/NJ School Board Association

John Gorman

On Board for 3 years, has 2 children currently in Long Valley schools, has child with IEP, currently works for YMCA, Board needs to be considerate of the needs of children, parents, teachers, school administrators and residents of town that don't have children in school currently

Jessica DeCicco

Has 4 children, 3 currently in Long Valley schools, was a substitute teacher and aide, active in PTO, started attending BOE meetings due to interest in teachers' contract difficulties; is very interested in maintaining quality special education services, is concerned with quality of middle school and preparation for high school, is concerned with transparency at BOE meetings, started live streaming BOE meetings, wants to explore alternate funding options, feels disconnected due to superintendent who is also director of special ed/special services

Comment-Regarding posting of minutes from BOE, commentor feels posting of minutes makes BOE accountable

Kelly DeMayo

Went through Long Valley school system, became involved with BOE when air quality concerns surfaced with Old Farmers Road school, feels area of spending can be improved buy many of our facilities need upgrades, at least 70% of tax dollars go to schools, need to ensure we have a safe, healthy buildings for students and teachers, need prioritized spending, need more transparency with BOE, wants more detailed and accurate board minutes as a matter of open public record, feels there is a need for more creative funding notes, doesn't see a system of checks and balances between board and administrators

Kiera Horutz-Mitchell

Went through Long Valley school system as a student, was involved in Cucinella PTO, is on Long Valley Middle School PTA, has had 2 different experiences with Special Education services especially literacy program, \$45 million budget for schools, wants easily accessible budget with direct link

Lisa Wooding

Self described "career volunteer", VP of Board last 5 years, president is from Mendham, feels important to have female presence on Board, right now there are 2 females and 7 males on Board, health care costs are always a concern, West Morris Central has International Baccalaureate program with multiple paths, is committed to maintaining facilities, have not had to put out referendum in many years, family meetings with guidance department start earlier, in the sophomore year; parent newsletter for WMCHS, focus on student wellness, stress management, homework free weekends; earlier start to school year hives 2 weeks extra over previous calendar for testing in May to put us more on par with many parts of the country, ChromeBooks, Board making sure teachers are integrating them into classrooms

Comment-advantages of making Washington Township a K-12 district instead of K-8 plus high school amounting to 2 superintendents, etc.would be advantages to have K-12 district

Clayton Zdroik

Sophomore at Rutgers University, was a student at WMCHS, wants to see improvements in technology, doesn't feel like 1:1 ChromeBooks necessary, wants better computers that can be shared; computer science department needs improvement, wants to advocate for foreign language education improvement

Motion to approve September's minutes, second, all in favor, approved

Budget, Treasurer's Report

- -Membership numbers doing very well, at the end of October, will be over projections
- -KidStuff about \$500 under budget

Proposal was made to amend budget for Children's Assemblies. Kindergarten and 1st grade were not able to go to Signature's Project assembly, would like to bring alternate assembly for \$895. The increase will be by \$895 from \$8505 to \$9400. Motion made to approve budget increase, seconded, all in favor, approved.
